8th National Seminar on Common Land and Town & Village Greens

The 8th National Seminar on Common Land and Town and Village Greens will take place on Thursday 1 July 2010 at the University of Gloucestershire's Park Campus in Cheltenham. We are particularly delighted that the recently formed Foundation for Common Land is supporting the event and that Defra and Natural England are also providing sponsorship. As ever we are also grateful for the wide-ranging support that the seminar continues to generate from a range of organisations, notably from the Association of Commons Registration Authorities which will be contributing an afternoon workshop.

The seminar is aimed at commoners, landowners and agents, practitioners, recreational users and institutions and all those involved in the management of commons and village greens.

Summary of Key Speakers

Julia Aglionby is a land agent with H&H Bowe Ltd and undertook the shadow commons council work in the Lake District with the Federation of Cumbria Commoners.

Mark Alexander is from the Office of the Chief Veterinarian Officer and heads up the bovine TB programme.

Kate Ashbrook is General Secretary of the Open Spaces Society.

Graham Bathe is Common Land Projects Manager with Natural England and is lead contact for Natural England on their flagship Common Land Project.

John Bell leads the Cattle ID and livestock movements policy team within Defra and has been developing the new rules on livestock movements.

Hugh Craddock is Head of the Commons Team within Defra.

Julie Dowton is a member of the Bodmin Moor Commoners Association, one of the first groups to consider becoming a pilot commons council.

Mervyn Edwards is an upland specialist within Natural England with particular responsibility for the recently introduced Upland Entry Level Scheme.

Jenny Griffiths is Commons Registration Officer with Powys County Council and a Chair of the Association of Common Registration Authorities.

Jeremy Holtom is Secretary to the Brendon Common Commoners Association in Exmoor.

The focus of the seminar will be on best practice to actively protect and manage common land and town and village greens in England and Wales, embedding the opportunities in the Commons Act 2006 into current and future management practices. Consequently, it will seek to showcase local examples of good practice, the new opportunities arising through commons councils, latest updates concerning the Commons Act 2006, financial support such as the Upland Entry Level Scheme and Glastir. The format will offer delegates an opportunity to raise their own particular issues in the wide range of afternoon workshops and discussions.

Commoners and others who are currently putting the Act into practice will share their experiences in the morning sessions. Particular attention will be paid to the range of responders and approaches as

Chris Short is Senior Research Fellow in the CCRI and has been convenor for the National Seminar since 1999. He has undertaken a wide range of research into commons and town and village greens.

Martin Steer heads the specialist casework branch of the Planning Inspectorate, which covers commons, rights of way, transport and environmental appeals.

John Waldon is now an independent facilitator and involved with the South West Uplands Federation having previously worked for the RSPB.

Cameron Watt is Neighbourhoods Policy Leader in the National Housing Federation with responsibility for areas including planning, rural housing and community land trusts.

Jon Westlake is heading up the development and implementation of the Glastir agri-environment scheme within the Welsh Assembly Government.

Angus Winchester is Senior Lecturer in the Department of History at Lancaster University and was co-investigator on the Contested Commons project.

Jim White is a senior ecologist with Footprint Ecology and was a member of the team that put together Natural England's new factsheets offering guidance to individuals and local communities on management of commons and greens.
